
01) Applicant's Brief,

- 04) Notice of inquiry was issued to the trustees as per No 16 , Its receipt have been placed ar no. 17 to 19 and 22. The applicant has filed his own and the trustee's (No. 24 and 25) affidavits and made a statement regarding the approval of the change application.
